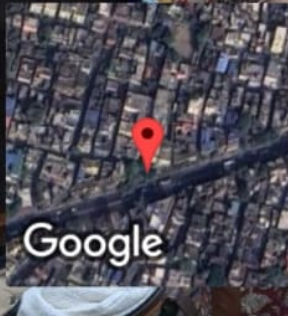

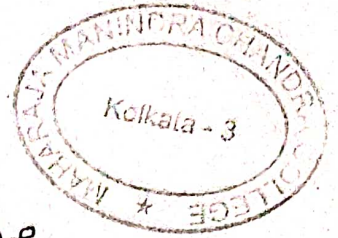

Any cooperation under this MOU is subject to the availability of funding sources and approval of the relevant authorities.


Settlement of Disputes:

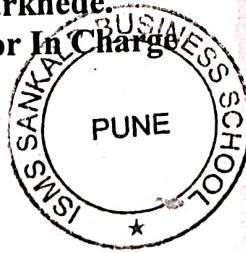
Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultations or negotiations between the Parties.

Governing Law: This MoU shall be governed by and construed in accordance with the laws of Government of India.

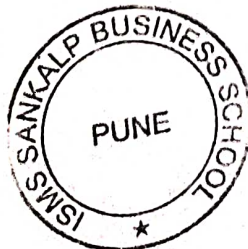
